Terms and Conditions

- 1. The TENS machine is supplied on the understanding that it will be used only by the person whose name appears on this form and is not transferable between individuals.
- 2. The TENS machine will be used following the instructions provided.
- 3. The success of TENS machine is neither guaranteed nor implied.
- 4. The TENS machine will be supplied to the best of our ability in perfect working order ready for use.
- 5. TENS should not be used by anyone suffering from epilepsy, fitted with a cardiac pacemaker or who suffers from (or is suspected of suffering from) heart disease.
- 6. Positively Birth Doula Services reserves the right to charge the replacement value of lost, stolen or damaged TENS units, part of a unit, or extras supplied as outlined below. The replacement cost may be charged if any TENS unit or part of a unit is returned contaminated with bodily fluids. Replacement value up to \$200.
- 7. Positively Birth Doula Services shall not be held responsible or liable for any injury or damage sustained as a result of misusing our TENS machine.
- 8. The return of the TENS unit to Positively Birth Doula Services rests with the renter, including arrangement for pick up.
- 9. The rental period is for 28 days. Should the unit not be returned by the last day of the rental period (unless otherwise agreed with Positively Birth Doula Services), an additional \$15 will be charged for each week or part of additional week that the unit fails to be returned. If the TENS is not returned for any reason the full replacement charge of \$200 will apply.

- 10. If your rental period expires before you have given birth, an extension to the 28-day rental period can be accommodated at no extra cost if agreed prior to the expiry date of rental with Positively Birth Doula Services.
- 11. In the event of a cancellation the rental fee will be returned less an administration fee of \$20. No refund will be made after the TENS unit has been dispatched to the renter or for non-use of a machine.
- 12. All Positively Birth Doula Services TENS machines are tested prior to dispatch. However, the liability of Positively Birth Doula Services shall not exceed the rental charge.
- 13. Positively Birth Doula Services reserves the right to alter Terms and Conditions of rental without prior notice.
- 14. TENS electrodes should be placed on the back according to the instructions. Use can begin during early labour. Unit can be placed on limbs during testing or practice after 36 weeks of pregnancy. Electrodes should not be placed on broken or inflamed skin.
- 15. Extra pads cost \$25 per set of four.
- 16. TENS Machines are NOT compatible with water. If you wish to have a shower or bath you must first turn off the TENS unit and remove the TENS pads from your skin.
- 17. It is the responsibility of the customer to check the contents of the rental package upon receipt and familiarize themselves with the TENS machine and user instructions. The customer must advise Positively Birth Doula Services of any problems whatsoever immediately. Positively Birth Doula Services accepts no responsibility where the customer fails to do so thereby rendering it impossible for Positively Birth Doula Services to take any corrective action. All pieces of the original package MUST be returned, this includes expired batteries.
- 18. The rental of the TENS unit for 28 days is \$75 to be paid after submission of contract.
